## Work-Sharing Program

Work-Sharing is an agreement between employers, employees and Service Canada to avoid layoffs during lower than average business periods. The Work-Sharing program allows employers to:

- ▶ continue their operations when they experience a temporary reduction in work activity;
- ▶ retain qualified and experienced workers and;
- ▶ avoid recruiting and training new employees.
